The School

Caterham Preparatory and Pre- Preparatory School is a co-educational IAPS day school for 300 pupils aged 3 -11 years. It is located in a beautiful valley site bordering the North Downs and surrounded by woodlands, 5 minutes from the M25 and only 20 miles from central London.

The school enjoys a strong Christian foundation and teachers are expected to participate in assemblies and other Christian celebrations during the year (e.g. Christmas and Easter). We have a highly proficient staff comprising of fully qualified teachers and teaching assistants. The emphasis on teamwork is important.

Class sizes are typically 20 and we enjoy excellent facilities, including extensive outdoor areas and ICT provision.

Pupils normally progress to the Prep-School for KS2 and ultimately the adjoining Caterham School, a co-educational day and boarding HMC school. The combined grounds of the two schools cover some 200 acres.

The schools share a common body of Trustees and together aim to be a family school for children from three to eighteen years of age. Both schools are proud of their combined reputation for academic excellence and the development of well-rounded individuals.
